

Regional Patient Advocacy Leaders Summit Roundtable Meeting Recap—Overview



The 2016 Election: How Does It Affect Patients

The Denver Regional PALS meeting was held in Denver, Colorado on December 1, 2016. About 40 patient advocates and policy leaders came together to discuss the theme “2016 Elections: How Does It Affect Patients”.

Based on a presentation by the Governor’s Senior Health Policy Advisor, patient advocates were encouraged to hear that Colorado will continue many of the health initiatives that have been adopted and are currently being implemented including reduction of obesity, preventing and treating diabetes, and providing quality air control to improve health, especially for the chronically ill and elders of our state. The State released the Strategic Plan on Aging on 11/30/16. The recommendations are being reviewed in light of the considerable shift in the number of seniors both currently living in Colorado and the increases in Baby Boomers reaching retirement and needing more health care that are expected in the next 25 years. Some initiatives that are specifically tied to the ACA will continue to be reviewed and discussed, but it is too early to have much detail on the decisions that will be made by the State. There is some concern that some of the current programs may be lost since Colorado is a Medicaid expansion state and runs their own exchange.



Looking at federal issues, Senator Bennet’s office noted there is less certainty on what is happening. While the Senator will be in the minority, he is well positioned to have input on decision-making for health bills. The Senator’s office expressed the need to look for common ground to come forward with the best health care plan for all Americans. A discussion followed using the California PALS slide on what we think “will stay”, “what will change”, “what’s new” and “what to watch for”. This provided a lively discussion in which advocates were able to begin to identify their role

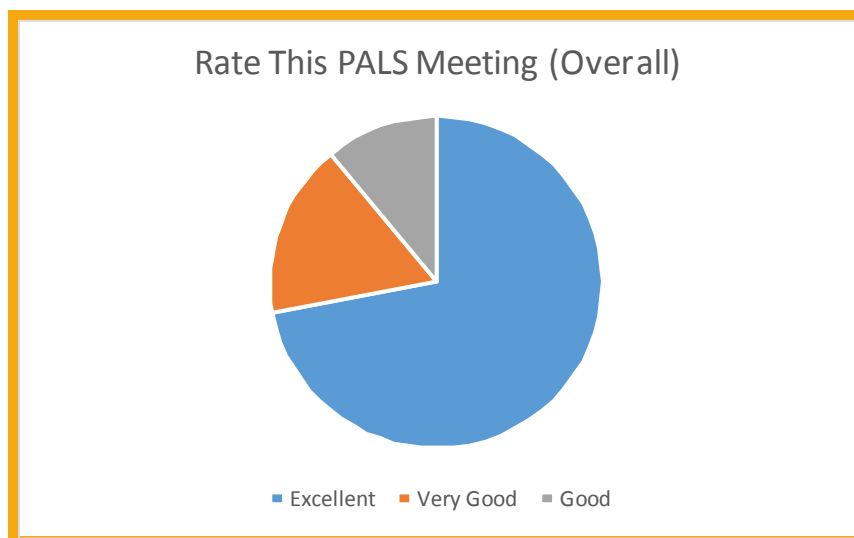
in federal policy as it relates to the ACA. Advocates were encouraged to share their concerns and to be ready to act with limited advance warning. Federal Staff stressed the best time to have input to changes is during the drafting of the bill, which often happens over a very short time period. There is some concern over the Ryan budget and what that may mean for many of the health programs.

The last presentation focused on state legislative issues that affect those with disabilities and seniors. Legislation has been passed to provide a caregiver for hospital patients both during admission and upon discharge to help with transitions to home. Another bill is being considered that would improve working conditions for home care workers. Advocates, as well as constituents, are the most important drivers of changes in policy. Communication and working closely with elected officials is critical to making these changes.



In summary, advocates were encouraged to continue their advocacy, to find ways to preserve the current “wins” and to provide input and suggest solutions on anticipated changes in the ACA by being involved and at the table early in the discussions. Federal advocacy will be key to keeping health insurance for those most in need of health care coverage.
